EDUCATION PROGRAMS AND REFERRALS: OUR CRITICAL EDUCATION PROGRAMS SERVE EVERYONE IN THE COMMUNITY WITH THE OPPORTUNITY TO UNDERSTAND AND PLAN THEIR FINANCIAL FUTURES. WE ALSO PRIORITIZE PREPARING LOW AND MODERATE-INCOME BUYERS FOR HOMEOWNERSHIP. THIS PROGRAM INCLUDES FREE FINANCIAL WORKSHOPS AND MULTI-SESSION ONLINE COURSES, FREE HOUSING COUNSELING INTEGRATING IN-PERSON AND ONLINE RESOURCES, AND FREE ADVOCACY AND ONE-ON-ONE REFERRALS IN-PERSON AND BY TELEPHONE. THIS ROBUST PROGRAM HELPS HARD-WORKING PEOPLE ACHIEVE ECONOMIC STABILITY. IN THE PAST YEAR WE SERVED MORE THAN 438 INDIVIDUALS AND 206 HOUSEHOLDS.
